Frequently Asked Questions (FAQs)

1. Why am I required to sign a "Proof of Lawful Presence Affidavit" for a child care license?

A child care license is considered a professional license, one of the items the state considers a public benefit. In 2006, the Colorado legislature passed a bill requiring that all governmental entities verify the lawful presence of any individual, eighteen years of age or older, applying for and receiving a public benefit.

Other public benefits, according to Colorado state law, include state grants, loans, commercial licenses, employee benefits (such as retirement, health, disability, and unemployment), public or assisted housing, postsecondary education assistance, etc.

2. What information does the State need from me?

To comply with state law, the Department must receive and keep identification information from an individual seeking a public benefit. The following types of identification are allowable:

- 1. A valid Colorado driver's license or a Colorado identification card
- 2. A current Out of State driver's license or ID card bearing applicant's photograph
- A valid U.S. Passport with a photo, except for "limited" passports, issued for less than five years
- 4. A United States military card or a military dependent's identification card
- 5. A Native American tribal identification card
- 6. A valid I-551 Resident Alien/Permanent Resident Card verified by Systematic Alien Verification for Entitlements (SAVE) with a photo

In addition to providing identification, the individual must affirm:

- 1. That he or she is a United States citizen or legal permanent resident; or
- 2. That he or she is otherwise lawfully present in the United States pursuant to federal law
